

THE PROCESS

It's quick, it's easy, and it makes a difference in your community!

- Determine your amount of PA tax Liability (PA 40, line 12).
- · Complete the pledge form (shown below) to hold your place in line.
- · Receive an award letter and check request from CPSF.
- · Send your contribution as directed by the CPSF letter.
- Receive a K-1 (receipt of contribution) to file with your taxes for the 90% credit.

THE HISTORY

Pennsylvania launched the EITC Tax Credit program in 2001 to allow a small number of taxpayers to pay their state income taxes to local private schools. These scholarships help low- and mid-income students attend the school of their choice.

The Basics:

- EITC tax credits through The Central Pennsylvania Scholarship Fund (CPSF) are worth 90% of the taxpayer's bill.
- EITC tax credits are awarded on a first-come, first-serve basis, so being early is critical.
- If you pay at least \$3,500 in annual PA state income taxes, you can pledge your tax dollars through EITC.



You can choose how your tax dollars are spent!



WHAT PERCENTAGE OF MY TAX BILL GOES TO THE SCHOOL?

100% of your contribution goes to the school for scholarship purposes.

HOW DO I QUALIFY TO DONATE MY TAX BILL?

If you pay \$3,500 or more in PA state income taxes each year, YOU QUALIFY!

WHEN CAN I GET STARTED?

Complete a pledge form TODAY to set aside these scarce tax credits for you and your school.

HOW LONG DOES IT TAKE TO APPLY?

It only takes a few minutes to complete the simple one-page pledge form.

CAN I DO THIS LATER?

Don't wait! Timing is critical because EITC tax credits are given on a first-come, first-serve basis — so complete the pledge form today!
