This includes income from all dependents living in your household and any child support. \*Note: Your school may have chosen lower income limits.
- Household income includes income from dependents. **Be sure to include tax returns filed by dependents listed on your tax forms.**
- We verify adjusted gross income and dependent count from the first page of IRS form 1040. If dependents are listed on a separate page, please include that page.
- If you did not file a 2022 tax return, include a signed statement of monies received in 2022.

FB Scholarship Services is a broad-based scholarship organization which serves schools across Pennsylvania. We specialize in providing comprehensive scholarship services, which includes financial evaluation of each family and a proposed tuition assistance amount. Our goal is to financially assist families that choose to educate their children in private and religious schools.

Available scholarship funds are derived solely from donor directed contributions designated to Faith Builders Scholarship Services. We can accommodate EITC donations, OSTC donations, and other types of donations.

Distribution of funds are needs-based according to family size, annual household income, and total tuition. Lower income families (EITC) and families living in low-achieving school attendance boundaries (OSTC) have a higher priority.

Scholarships are available for any student who is a Pennsylvania resident attending a Pennsylvania school under the following guidelines:

- The school needs to file a School Application with Faith Builders.
- The family needs to complete a Family Application for the scholarship funds.
- Scholarships for qualified students will be paid directly to the participating school.
- Scholarship funds are available only at schools that have received donor recommended funds.
